#### SPONSOR RESPONSIBILITY (THE LEAGUE)

- 1. PROMOTION: Each horse show will be named in all advertising listing the sanctioned events and the League Finals.
- 2. STANDINGS: The standings in each division will be updated and the results published.
- MAILING: The League will provide access to an up-dated mailing list of League Members upon request.

#### SHOW RESPONSIBILITY (HORSE SHOW)

- 1. DUES/RESULTS/REGISTRATION: The Horse Show will furnish to the League Office within **ten (10)** days of the conclusion of the event the following:
  - A. DUES: Show Dues has been waived for all shows for the 2025 Season.
  - B. RESULTS: 1) Complete results including Horse, Owner, Rider, and Prize Money Won, where applicable. 2)Results must also provide Owner and Rider addresses. 3) When classes are combined, results must indicate which section points are to be awarded. 4) If a show is canceled, please inform The League of the name and show date. 5) Results not received within 20 days of the conclusion of the show will be considered to have been canceled.
  - C. MEMBERSHIP: Completed League rider membership forms and membership fees must accompany results.
- 2. SPECIFICATIONS: League Specifications must be posted at the Show Office for exhibitors. The Event must follow the rules and regulations as set forth in the Specifications.
- 3. PROGRAM/PRIZE LIST: The League requires two (2) full-page black & white advertisements in the horse show prize list and/or program:
  - A. The League Advertisement (REQUIRED) Available online at: HITSShows.com
  - B. Marshall & Sterling Insurance Advertisement (REQUIRED) Available online at: HITSShows.com
- 4. LEAGUE PROMOTION:
  - A. Member Shows will make available to exhibitors the current membership forms, specifications, and other promotional materials supplied to the horse show by the League.
  - B. Member Shows will display promotional materials supplied by the League.
  - C. Member Shows will provide the League with public announcements during each day of the event.
- AWARDS PRESENTATION: The League will have the opportunity to make the official presentations to the winning riders.
- 6. SAFESPORT COMPLIANCE: Member-shows must complete and sign the compliance portion of this agreement listing the names, dates and USEF #s (if applicable) of all shows hosting League classes. *There is no substitution or exception to this portion of the agreement.*
